## Historical Sketch:

The Citrus Processors Meetings began in 1950 as part of the collaboration between the University of Florida's Citrus Experiment Station (now known as the Citrus Research and Education Center) in Lake Alfred, Florida and the Florida Citrus Commission (now known as the Florida Department of Citrus). The collaboration between the two organizations initially began in 1947, after the 1941 Florida Citrus Code established the creation of a Florida Citrus Commission research department to be housed at the Citrus Experiment Station. Each year, researchers have gathered at these meetings to share their latest research as well as industry news. By 1999, the event had become known as the Annual Citrus Processors' Day.
